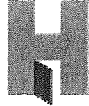
**RECOMMENDATION OF SUPERINTENDENT:**

**BACKGROUND:**

The School Board approved a Cosmetology contract with Hennepin Technical College (HTC) on May 23, 2016 to provide cosmetology instruction at the Bloomington Career and College Academy (BCCA) during the 2016-17 school year. The addendum includes additional costs incurred due to increased enrollment in the program. The cost of providing instruction increased to \$56,560.00.

AMENDED PARAGRAPH**

**ADDENDUM TO CONTRACT #17004**

WHEREAS, the Board of Trustees of the Minnesota State Colleges and Universities, on behalf of Hennepin Technical College (hereinafter "the College") and Independent School District No. 271 of Hennepin County, Attn: Gary Kressin, 8800 Queen Avenue South, Suite 219, Bloomington, MN 55431 (hereinafter "the Contractor") have entered into a contract; and

WHEREAS, the College and the Contractor have agreed that additional provisions are necessary to implement the contract; and

WHEREAS, paragraph IV. A. of the contract of the parties provides that:

**IV. CONSIDERATION AND TERMS OF PAYMENT.**

A. Cost of Instruction: fifty thousand five hundred sixty dollars (\$50,560.00).

NOW THEREFORE, IT IS AGREED BY AND BETWEEN THE PARTIES HERETO:

That the paragraph IV. A. shall be amended to read:

**IV. CONSIDERATION AND TERMS OF PAYMENT.**

A. Cost of Instruction: fifty-six thousand five hundred sixty dollars (\$56,560.00). This amount reflects additional sections of cosmetology courses and increased instructional hours required to accommodate higher enrollment numbers than initially expected.

Except as herein amended, the provisions of the contract remain in full force and effect.
